### REGISTRATION IN AN ACADEMY (2021-2022)

Responsible parties whose wards have been offered a seat in an academy should call at that academy, in alphabetical order, on **14 June 2021 between 09:00 and 15:00** for registration formalities.

Responsible parties should bring along the following documents:

- National Identity Card of the Responsible Party (original + 1 photocopy)
- Birth certificate of the student (original + 1 photocopy)
- Result Slip of the student (original + 1 photocopy)
- Admission letter
- 2 passport-sized photographs

***In case a responsible party does not report to the academy allocated to his/her ward for registration purposes on 14 June 2021, the seat will be declared vacant.***

### REPORTING TO REGIONAL SECONDARY SCHOOLS FOR GRADE 10 (2021-2022)

Responsible parties whose wards will move to Grade 10 in their current regional school should call at his/her school on **14 June 2021 between 09:00 and 15:00** in alphabetical order for formalities:

### REVIEW OF SCRIPTS

- Responsible parties who are not satisfied with the assessment results of their ward may apply for a review of his/her scripts by filling the online form on the MES website <http://mes.intnet.mu> under heading of Examinations and NCE.

The Mauritius Examinations Syndicate should be informed in writing by **01 September 2021** at latest of any request for correction of names. Such requests should be accompanied by a copy of the birth certificate and the result slip of the candidate.

**A fee of Rs 65 per entry will be charged.** Please note that, in accordance with the NCE Regulations, no request will be entertained after the deadline.
