# ADMISSION TO GRADE 10 (YEAR 2023) REVIEW OF SCRIPTS - CORRECTION OF NAMES

#### **REGISTRATION IN AN ACADEMY**

Responsible parties whose wards have been offered a seat in Grade 10 (year 2023) in an academy should call at that academy on **Thursday 22 December 2022 between 09:00 and 15:00** for registration formalities.

Responsible parties should bring along the following documents:

- National Identity Card of the Responsible Party (original + 1 photocopy)
- Birth Certificate of the student (original + 1 photocopy)
- Result Slip of the student (original + 1 photocopy)
- Admission Letter
- 2 passport size photographs

In case a responsible party does not report to the academy allocated to his/her ward for registration purposes on 22 December 2022, the seat will be declared vacant.

#### **REVIEW OF SCRIPTS**

Responsible parties who are not satisfied with the assessment results of their ward may apply for a review of their scripts by filling the prescribed form available at the Mauritius Examinations Syndicate, NCE Section, Réduit.

The application form together with a copy of the result slip of the candidate should be submitted within the following period:

A fee of Rs 192 per subject will be charged.

#### **CORRECTION OF NAMES**

The Mauritius Examinations Syndicate should be informed in writing by **01 March 2023** at latest of any request for correction of names. Such a request should be accompanied by a copy of the Birth Certificate and the result slip of the candidate.

**A fee of Rs 65 per entry will be charged**. Please note that no request will be entertained after the date limit in accordance with the NCE Regulations.
